**No. HMB (F) 6-1/96-II.**—In exercise of the powers conferred by Section 84 of the Himachal Pradesh Agricultural and Horticultural Produce Marketing (Development and Regulation) Act, 2005 the H. P. State Agricultural Marketing Board hereby makes following bye laws to amend the Himachal Pradesh Agricultural Produce Market Committees Bye Laws-2007" notified *vide* Notification No. HMB (F) 1-4/2004 dated 1st September, 2007 published in the Rajpatra, Himachal Pradesh on 22-9-2007, namely:—

**1. Short title and Commencement.**—(i) These Bye Laws may be called the Himachal Pradesh Agricultural Produce Market Committees (Amendment) Bye-Laws, 2012".

(ii) These shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

**2. Amendment of Bye laws 47.**—For bye law 47 of the Himachal Pradesh Agricultural Produce Market Committees Bye-Laws-2007" the following shall be substituted, namely;

**“47. The scale and the rates of remuneration.—(1)** The scale and the rates at which various market functionaries may claims remuneration for services rendered within a notified market shall be *determined and specified hereunder*:—

(A) CEREALS, PULSES AND OIL-SEEDS.

*Market charges Commission*:—Not exceeding Rs. 2.00 per hundred rupees of the value of the produce.

(B) FRUITS, VAGETABLES, CONDIMENTS AND SPICES, ETC.

*Market charges Commission*:—Not exceeding Rs. 5.00 per hundred rupees of the value of the produce.

## (C) FIBRES, WOOL AND NARCOTICS (TOBACOO)

*Market charges* Commission – Not exceeding Rs. 2.00 per hundred rupees of the value.  
*Auction charges* – 50 paise per hundred rupees of the value.  
*Brokerage* – 50 paise per hundred rupees of the value.

(2) *The Agricultural Produce Market committee(s) may specify, determine incidental charges for principal yard/sub yard(s)-wise, in its jurisdiction bearing in mind the local conditions of market area in respect of followings;*

## (A) CEREALS, PULSES AND OIL-SEEDS.

*unloading*  
*cleaning and dressing*  
*Weighment charges.*

## (B) FRUITS, VAGETABLES, CONDIMENTS AND SPICES, ETC.

*Loading-unloading*  
*Weighment charges.*

## (C) ANIMAL HUSBANDRY PRODUCTS AND VEGETABLE OIL EXCLUDING WOOL.

*Unloading*  
*Weighment charges.*

## (D) FIBRES, WOOL AND NARCOTICS (TOBACOO)

*Unloading*  
*cleaning and dressing*  
*Weighment charges)*  
*Sewing*

*Provided further;*

- (i) *Agricultural Produce Market committee(s) may determine, approve, and notify incidental charges in the manner as specified above till then existing provisions will deem to be applicable.*
- (ii) *The loading and weighment charges after the finalization of the bid shall correspond with those specified under incidental charges.*
- (iii) *The producer-seller will be entitled to remission of unloading charges if he himself performs such functions as are clubbed under unloading charges.”*
